



LOCATION

The Hunslet Trading Estate is a long established commercial centre situated to the South of Leeds City Centre within easy reach of the motorway.

The surrounding area is of long established industrial properties.

DESCRIPTION

The subject property is a modern semi detached industrial unit of steel frame construction with brick and metal clad elevations.

Internally, the unit incorporates a showroom at ground floor with an ancillary meeting room/office with warehouse and storage facilities behind.

There is an office/meeting room at first floor.

The building has a clear working height of 5m and access to the workshop area is through a full height electrically operated roller shutter door.

The building is fully lit.
